Tennis members may play all they want subject to court availability, and may call in to reserve a court one week in advance. Free summer tennis is reserved for outdoor courts only. Indoor play is subject to court availability and a fee of \$25 per hour. We require at least 24 hours notice of cancellation for random reservations and lessons or player will be billed.

Reserved time will be limited to 1.5 hours for singles and 2 hours for doubles.

All courts will be available on a first come first served basis.

Management also reserves the right to revoke without refund, the membership of any member not following the rules and regulations or acting in an inappropriate manner and to amend the rules and regulations as may be necessary.
